- 3. Application requesting for detailed Bid documents must be accompanied with relevant documents in support of their own nursery. The office will physically inspect the nursery owned by the contractor , if required. The tender paper will not be issued to those who do not have their own nursery.
- 4. Bid documents will be issued only to prospective bidders who have experience in doing similar nature of works or maintain potted plants and outdoor garden works in Government Department / PSU's / Boards etc. and also satisfy the following eligibility criteria:-
 - (i) Average Annual Financial Turnover during the last 3 years, ending 31st March of the previous financial year, should be at least ₹ 0.70 Lakhs i.e. 30% of the estimated cost.
 - (ii) Experience of having successfully completed similar works during last 7 years ending last day of month previous to the one in which applications are invited should be either of the following:-
 - ▶ 3 (three) similar completed works costing not less than ₹ 0.93 lakhs.

Or

▶ 2 (two) similar completed works costing not less than ₹ 1.16 lakhs

Or

- ▶ 1 (one) similar completed works costing not less than ₹ 1.86 lakhs.
- * * *Similar works means supply and maintenance of potted plants(indoor and outdoor)including outdoor garden etc.

The intending tenderer must submit documentary evidence in support of (i) and (ii) above in the form of certified copy of work order/ LOI having BOQ and copy of completion certificate/ certified (accepted) copy of final bill/ payment certificate/ vouchers indicating the period of work for which the payment has been made.

- d) Service Tax Registration number if applicable. In case service tax is not applicable, tenderer has to submit an affidavit in this regard.
