(**NEEPCO Ltd.**), a Central Public Sector Enterprise under the Ministry of Power, Government of India, intends for empanelment of Indian Individual/Joint-Venture Integrated Steel Producer Firms/their authorised Distributor for supply of TMT reinforcement steel and structural steel required for its various Hydro Electric and Thermal Power Projects situated across the North Eastern States of the Country and hereby invites “Expression of Interest(EOI)” with 180 days validity from intending applicants.
2. **Category of Panels & validity:** NEEPCO plans to form a panel from Integrated Steel Producers for the following categories of Steel Materials for a period of one year that may be extended in future at the discretion of NEEPCO.

Sl.	Category
1.	For supply of TMT Reinforcement Bar
2.	For supply of Structural Steel

Empanelment shall be done separately for each of the above different categories. The applicants are required to specifically mention the Category/categories of their interest for empanelment.

3. **Tender & Order for supply:** As and when steel material requirement would arise, NEEPCO may invite Offer/Bid/Quotation for supply of material from the empanelled Integrated Steel Producers/their authorised Distributor. However, NEEPCO in no way shall be bound to place any order to any or all of the empanelled firms.
Terms of reference, payment terms, time schedule and, other relevant terms and conditions will be defined for each supply works separately at the stage of inviting Offers/Bids/Quotations or while awarding the Supply Order. NEEPCO's decision in the matter of tender and award of Supply Order shall be final.
4. **Eligibility Criteria:** Applicants, who intend to participate in the ‘Expression of Interest’, shall be Indian Individual/Joint-Venture Integrated Steel Producer Firms having plant and business operated in India and also having a minimum 5 (five) years of experience in commercial production of the above required products, only are eligible

Non-performance/under-performance/objectionable activity of an empanelled Steel Producer can affect award of future Supply Order to him/her and may even result in its removal from the panel at the discretion of NEEPCO.

2.	Power of Attorney of the Applicant, authorizing the signatory of the EOI to commit on behalf of the Applicant.
3.	Valid BIS License of their products.
4.	Valid ISO Certification from recognized body.
5.	Particulars of Technologies acquired/procured and implemented by the Company for steel production along with proof in the form of License, Rights, Association, Agreement etc.
6.	Source of Raw materials for the plant and agreement for supply or linkage/ownership of raw materials along with necessary supporting documents.
7.	List of Government Department, Central public sector Enterprises, Prestigious Projects and other Industrial Establishments where materials has been supplied for last 3 (three) years with documentary proof.
8.	Proven Technology of manufacturing (as applicable) should be submitted along with documentary evidence/ literature, if any.
9.	Annual Turn-over of Company (not less than 200 crores)/Audited Accounts for last 3 (three) years to be submitted .
10.	Test certificates of Products from the reputed laboratories accredited by NABL.
11.	Mention the category of interest for empanelment for which applied (i.e., for supply of TMT reinforcement bar or structural steel or both).
12.	Capacity of manufacturing unit should not be less than 0.5 MMTPA.
13.	List of Directors/Partners of the Company.
14.	Registered name of Company, Company Registration No. and date with copy of Registration Certificate.

All pages of the submittals shall be signed and sealed by a person or persons, duly authorized to sign on behalf of the Applicant.

Applications found containing incorrect/disputed information/declarations shall be liable for rejection at any stage of the processing for empanelment.
