- 7) **Price:-** Rate shall be quoted both in figure and words in Annexure-I & II at FOR Basis at Kopili HE Plant, NEEPCO Ltd., Dima Hasao, Assam approximately 257 Km from Guwahati and at Agartala Gas Turbine Project, C. C. Extension Project, NEEPCO Ltd., Ramchandra Nagar, Agartala, Tripura approximately 600 Km from Guwahati.
- 8) **Tax:-** CST/VAT as applicable shall be paid extra. Necessary C-Form shall be issued against CST by the Paying Authority.
- 9) **Delivery:-** Delivery of material shall be completed within 45 (Forty Five) days from the date of issue of Purchase Order.
- 10) **Quantity Variation:-** Quantity variation upto  $\pm 5\%$  is acceptable.
- 11) **Payment:-** Payment shall be made within 30 (Thirty) days of delivery of material in full and good condition at site. Payment shall be made through RTGS for which Bank details should be submitted by the Bidders with their Bid.
- 12) **Insurance:-** Transit Insurance shall be borne by the Supplier.
- 13) **Losses or damages in transit:-** Supplier shall be fully responsible for all losses/damages/shortages in transit up to delivery point. Payment will be effected only for the delivered quantity at delivery point in good condition.
- 14) **Penalty for delay in delivery:-** The delivery period for supply will be the essence of the orders issued from time to time. In the event, the successful bidder fails to supply within the stipulated delivery period as indicated in the Supply Order without valid and convincing reasons, penalty will be levied to the extent of **0.5 % (zero point five percent)** per week subject to maximum of **15 % (fifteen percent)** of the order value of the goods in respect of which the default in delivery takes place. The Corporation reserves the right to adjust liquidated damages either against the Performance Security Deposit or any amount that may be due or becomes due to the Supplier in any form.
- 15) **Force Majeure:-** Within the stipulated period, if delay has occurred due to "Force Majeure" conditions, which are beyond the control of the Supplier, payment of penalty as per Clause No. 12 by the Supplier to NEEPCO Ltd., on account of delay in delivery may be waived at the discretion of the Executive Director (MM). The Supplier shall, however, apply to the Executive Director (MM) for waiver of payment of Penalty/Liquidated damages in such cases, supported by documentary evidence of such occurrence. Decision of the Corporation as regards to acceptance of the reasons stated by the Supplier vis-à-vis imposition of penalty is final and binding on the Supplier.
