7. **Guarantee**: The materials shall be guaranteed for a period of 12(twelve) months from the date of receipt for any manufacturing defect or faulty workmanship, otherwise as per manufacturer norms.
8. **PAYMENT** : 90 % (Ninety percent) payment will be released after receipt of the material in full and in good condition at Project Site against submission of bill. Balance 10 % (Ten percent) will be kept as Performance Guarantee till the completion of guarantee/Warrantee period. OR 100% (Hundred percent) payment will be released after receipt of materials on submission of **Performance BG** in NEEPCO Format equivalent to an amount of 10% (ten percent) of the total order value. Payment term is firm. The Performance BG will be released after expiry of guarantee/warrantee period.
