 - c) Three completed works each costing not less than the amount equal to 40% of the estimated cost.
 - d) Solvency Certificate from any Nationalized Bank.

 - III. Certificate to be enclosed as a proof of SC/ST.
 - IV. Labour licence .
 - V. P.F. Registration no.
