Earnest Money shall be furnished in the form of **Call Deposit / Fixed Deposit** in favour of NEEPCO Ltd, TrHEP from any Nationalised / Scheduled Bank payable at State Bank of India, Vairengte Branch. The said earnest money will be 50% in case of tribal supplier on submission of necessary ST Certificate from the Competent Authority.

Submission of tender document shall invariably accompanied by requisite earnest money as indicated above. Latest Income Tax Clearance Certificate / Exemption Certificate (for ST)/ Copy of PAN Card are to be submitted along with the Tender Document.

Tender not accompanied by the requisite EMD shall be rejected. If the Tenderer withdraws his tender during the tender validity period, the EMD shall be forfeited.

The tender will be received up to **13.00 Hrs.** on **19.08.13** in the O/O the Head of Project, Tuirial H.E. Project and the same will be opened at **15.30 Hrs.** on the same date in presence of the tenderers or their authorized representatives, if any.
