The meeting was chaired by the Executive Director (C&P), NEEPCO, who welcomed all the participants and briefed them on the objective of the meeting.

During the meeting, the queries raised by the prospective bidders were discussed in detail. Some of the major issues discussed during the course of the meeting are summarized below:

1. Provisions stipulated in the Technical Qualifying Requirements and Evaluation Criteria specified in the Bid Document / ATC.
2. Provisions stipulated in the Terms of Reference in the Bid Document / ATC.
3. Request for extension of the bid submission date.

NEEPCO explained the relevant provisions of the Bid Document / ATC and addressed the queries raised by the participants.

Prospective bidders were requested to submit their pre-bid queries in writing, except those bidders who had already submitted their queries earlier.

NEEPCO further informed that the clarifications to the pre-bid queries shall be issued and uploaded on the tender portal in due course.




