Therefore, as requested by bidders, the List of employees in MS Excel format shall be provided to the bidders individually on request.
2	Are all employees working on high tension supply.	NEEPCO owns and operates generating stations involving transmission wires of varying voltages ranging from 415V to 400KV. Transmission and distribution lines for electrification also exist in all our premises. Some of the employees of the power stations work in the High Voltage Systems whenever needed, after taking due safety precaution. Although standard protocols and safety norms are followed in such installations, risk of accidental exposure to live wire transmission cannot be ruled out.
3	Can we get the bifurcated data with the employees who are working on high tension supply or fireman, technician, electrician etc.	Designation of the employees are already mentioned in the List of Employees at Section IV of the Detailed Bid Document. Further bifurcation of data indicating the details of employees working on high tension supply may not be possible
4	What is the job roll of Khalasi in power sector unit or elaborate the work profile of the employees designated as Khalasi.	There is no specific job description for the employees designated as Khalasi. They are generally engaged in construction, maintenance & other Misc. works to assist the skilled personnel.


