

2	With reference to your tender NIB NO. 426 DATED 06.09.2022, we just wanted a clarification about submission of bid EMPANELMENT OF INTERNAL AUDITOR IN NEEPCO FOR THE FY -2022-23, 2023-24 & 2024-25, it is to only to be submitted online or we have to send the hard copy also. As such it is not mentioned in the bid about hard copy though we are clarifying on safer side.	Documents submitted online will be accepted unless specifically mentioned in Bid document in the bidding process.
3	We have a branch office in Agartala, Tripura & Our Head Office in Kolkata, West Bengal. We can execute the Internal Audit of your organization from both the places as we have a full-fledged office in both these states and we have GST registration in both the states. Please clarify which GST number we will put in our application for Empanelment. Also request you to clarify that if we quote the GSTN for our head office located in West Bengal, will be denied the 5 marks allotted for having branch offices in North East India? Accordingly, we shall quote the GSTN.	Please refer Sl. No. 9 under Clause-18, Section-III of the Bid Document. Accordingly, bid stipulation shall prevail.

The NIB No. 426 dated 06.09.2022 does not include qualifying mark for "Consultant" under the "Selection criteria for empanelment of Internal Audit in NEEPCO". In this regard, please refer to Clause 18 "SELECTION CRITERIA (ALLOCATION OF POINTS) FOR EMPANELMENT OF AUDIT FIRMS", Section-III, of the Bid Document.
7	In sub-point (5) of Point No. (23) It is required to submit the Certificates issued by the respective Institutes in evidence of qualification of Semi-qualified Assistants. Kindly confirm whether CA Intermediate (IPCC) Certificate will be sufficient.	For CA- intermediate, IPCC certificate is required.
